EXTENSION LICENSE AGREEMENT

THIS EXTENSION LICENSE AGREEMENT ("Agreement") is between the customer (individual or entity) that has downloaded or otherwise procured the extension ("you") and Inovista Ltd. ("Publisher"). You acknowledge that you are obtaining only a limited license right to the Extension and that irrespective of any use of the words "purchase", "sale" or like terms hereunder no ownership rights are being conveyed to you under this Agreement or otherwise.
- 2. LICENSE RESTRICTIONS.
